

### Restrictions, Winner Selection, & Award

"With Pride, We Prosper...Help Keep It Clean" Poster Contest is open to students enrolled in Charles County Schools. CCG staff judges will determine one winner from each grade group:

**GRADES K-2 • GRADES 3-5 • GRADES 6-8**

Each submission will be judged on creativity, originality; and appropriateness to the theme.

Each winning student will receive four tickets to a Blue Crabs baseball game, and a **CHOICE** of one the following:

**CHOICE #1:** Youth summer membership card to a local pool operated by the Dept. of Community Services. *Note: adult supervision required for age 12 and younger.*

**CHOICE #2:** A brand new bike provided by the Dept. of Public Works, Environmental Resources Division.

Winners will be contacted by **June 1, 2013**, and announced publicly during an episode of the Charles County Government's **Get Connected News Show**. The Charles County Commissioners will present the prizes and a certificate to each winner during a scheduled Commissioner Session. The winning posters will be displayed at the Charles County Government Building.

### Official Rules

All participants must read and abide by these Official Rules governing the Contest. Students agree to the Official Rules with their Submission.

### Grant of Rights

Winners agree to sign any documents that may be necessary to affect the assignment of the licensing rights.
