By repealing in its entirety:

- Sections 209.1 through 209.27, inclusive
- Code of Charles County, Maryland*
- (2013 Edition)*

**SECTION 1. BE IT ENACTED BY THE COUNTY COMMISSIONERS OF CHARLES COUNTY, MARYLAND, that the Laws of Charles County, Maryland read as follows:**

**CHAPTER 209**

**SELF-INSURANCE FUND**

**SECTION 2. BE IT FURTHER ENACTED THAT THIS ACT SHALL TAKE EFFECT ON THE DATE OF ADOPTION.**
