The below mentioned JPG #'s were delivered to Rick Turners during off business hours, Sundays or Federal Holidays which were restricted:

Any photos that are blurry are because the vehicles were traveling too fast for the camera shutter to catch clearly. There were many more restricted deliveries made by drivers driving too fast for the camera to catch a photo. This is just an indication of restricted deliveries made within one months' time frame. This further proves that any exception, variance or condition will not be honored by Rick Turner and his Slaughterhouse operation.

This is just a small indication of the traffic we on Petzold Drive are dealing with. The first seven days traffic was monitored there were 1767 Passes on Petzold Drive.

From November 22nd through January 20th there were 6309 Passes on Petzold Drive.

There are only 11 houses past where traffic was monitored and most of those residents are retired and do not go out much.
