17 (a) THE COUNTY COMMISSIONERS, WITH THE APPROVAL OF THE SHERIFF,
18 MAY ENTER INTO MUTUAL AID AGREEMENTS WITH OTHER MUNICIPAL
19 AND COUNTY'S LAW ENFORCEMENT AGENCIES WITHIN THE STATE OF
20 MARYLAND TO DETERMINE THE CIRCUMSTANCES UNDER WHICH
21 MEMBERS OF THE SHERIFF'S OFFICE MAY LAWFULLY GO OR BE SENT
22 BEYOND THE BOUNDARIES OF CHARLES COUNTY TO ANY PLACE WITHIN
23 THE STATE AND TO DETERMINE THE CIRCUMSTANCES UNDER WHICH
24 MEMBERS OF OTHER MUNICIPAL AND COUNTY LAW ENFORCEMENT
25 AGENCIES MAY LAWFULLY ENTER THE BOUNDARIES OF CHARLES

28 (b) IT IS THE INTENT OF THIS PARAGRAPH TO MAXIMIZE LAW ENFORCEMENT
29 PERSONNEL AND EQUIPMENT IN ORDER TO RENDER PROMPT, EFFECTIVE,

1 AND PROFESSIONAL SERVICES TO THE PUBLIC AS AUTHORIZED IN THE
2 CRIMINAL PROCEDURE ~~PUBLIC SAFETY~~ ARTICLE, SECTION 2-105 OF THE
3 ANNOTATED CODE OF MARYLAND.

5 **SECTION 2.** BE IT FURTHER ENACTED, that this Act shall take effect [FORTY-
6 FIVE (45)] calendar days after it becomes law.
