22 **SECTION 1. BE IT ENACTED BY THE COUNTY COMMISSIONERS OF CHARLES**  
23 **COUNTY, MARYLAND, that the Laws of Charles County, Maryland read as follows:**

25                                    **CAR SALES**

26 **SECTION 18.01. SUNDAY CAR SALES**

27 (A) NEW OR USED CAR DEALERS ARE AUTHORIZED TO SELL, BARTER,  
28 DELIVER, GIVE AWAY, SHOW, OR OFFER FOR SALE A MOTOR VEHICLE OR  
29 CERTIFICATE OF TITLE FOR A MOTOR VEHICLE ON SUNDAY.

31 **SECTION 2. BE IT FURTHER ENACTED, THAT THIS ACT SHALL BECOME EFFECTIVE**  
32 **ON OCTOBER 1, 2014, CONCURRENTLY WITH THE PROVISIONS OF CHAPTER 395,**  
33 **LAWS OF MARYLAND, 2014.**


