

COUNTY COMMISSIONERS OF CHARLES COUNTY, MARYLAND
Resolution Number 2009-109

WHEREAS, the County Commissioners of Charles County, Maryland adopted Resolution 97-107, effective November 29, 1994, as amended by Resolution 95-14, in order to establish and designate the Charles County Mental Health Authority, Inc., as the County Core Service Agency that is responsible for planning, managing, and monitoring publicly-funded mental health services as further provided in Section 10-1201, et seq., of the Health General Article, Md. Code Ann.; and

WHEREAS, on motion made, duly seconded and carried on the 20th day of August 1996, the County Commissioners of Charles County agreed to establish and designate the Charles County Local Management Board as the local management board to ensure the implementation of a local, interagency service delivery system for children, youth and families; and

WHEREAS, the County Commissioners of Charles County on motion made, duly seconded, carried and adopted Resolution 99-77 on the 26th day of July 1999, establishing the Human Services Partnership as an agency within Charles County Government incorporating the missions of the Local Management Board and the Core Service Agency into a single entity serving families, children, and consumers of the public mental health system in Charles County; and

WHEREAS, the County Commissioners of Charles County on motion made, duly seconded, carried and adopted Resolution 05-82 on the 2nd day of December 2005, to continue the Human Services Partnership as an agency of Charles County Government; and


WHEREAS, the County Commissioners of Charles County have determined that the placement of the Core Service Agency within the Charles County Department of Health and the Local Management Board to continue as an agency of Charles County Government will continue to maximize economic and programmatic efficiencies and provide greater accountability in the provision of human services to the residents of Charles County;


NOW, THEREFORE, IT IS HEREBY RESOLVED, this 17th day of November, 2009 by the County Commissioners of Charles County as follows:


- I. Dissolution of Resolution 99-77 and 05-82
- II. Ninety (90) day notice to the Secretary of Health that indicates placement of Core Service Agency as provided in Section 10-1201, et seq., of the Health General Article, Md. Code Ann., as a part of the organizational structure of the Charles County Department of Health
- III. Abolish Human Services Partnership
- IV. Continuation of the Local Management Board as defined and described in Maryland Governor Robert L. Erlich's Executive Order 01.01.2005.34, reference: "Governor's Office for Children – Children's Cabinet – Advisory Council for Children" as part of Charles County Government.


AND, IT IS FINALLY RESOLVED, that this Resolution is effective this 17th day of November, 2009.
