Welcome to the Charles County Government FY 2014 Budget Process. A few changes have been made to this year's application and Grant Budget/Reporting Summary to include the Commissioner's Vision 2020 Pilot Program Model.

The application is available electronically in Word format on our website at www.charlescounty.org. (Click "Departments" on the top bar, scroll down to Department of Fiscal and Administrative Services and click on "Grants Awarded by the County") There will be a link to the Welcome Letter, the FY14 Application for Grants Awarded by the Board of County Commissioners and the Grant Budget/Report Summary Instructions and Forms.

The Grant Advisory Panel is holding a **MANDATORY** training session on the FY14 application and Grant Budget/Report Summary requirements. For your convenience we have two sessions scheduled. One on Wednesday, December 12, 2012 from 9:00 – 11:00 am and the second on Friday, December 14, 2012 from 2:00 – 4:00 pm. Both sessions will be held in the Commissioner Meeting Room at the Charles County Government Building in La Plata, MD. Please be aware the application is for agencies with IRS 501(c)(3) status only and the deadline for submission has been extended to **February 1, 2013**. **In accordance with the County Code, all applications received after 4:00p.m. on February 1, 2013 and incomplete applications will not be considered.** We anticipate the final adoption of the budget in June 2013. As in the past, you will receive a grant notification letter shortly after the budget is adopted.
