

Stormwater Remediation Fee Credit Application

Instructions:

- 1. No application fee is required.
2. Check appropriate credits, for a maximum of 50% credit, which will be applied for three years.
3. Provide verification documentation in the form of copies of documents, receipts, photos, etc.
4. Return the completed form with appropriate verification documentation to: Charles County Department of Planning and Growth Management, Planning Division, P.O. Box 2150, La Plata, MD 20646.
5. Form and verification documentation must be received by October 31st of the year prior to the Tax Bill to which the credit will be applied.
6. Credit will be applied to next year's Tax Bill.

b) \_\_\_\_\_ The subdivision and/or housing development or individual home was constructed prior to July 1, 2001 but the property includes the use of one or more of the following stormwater management treatments and therefore my property qualifies for a 50% fee credit:

  - \_\_\_\_\_ ii. A rain garden to capture stormwater runoff from at least 800 sq. ft. of impervious surface;

  - \_\_\_\_\_ iv. Home Landscape is "Bay-Wise" certified;

**2. For agricultural and forested property, verify and check which of the following applies:**

- a) \_\_\_\_\_ My property is covered by a current Forest Management Plan, prepared by a licensed Forester. Therefore my property qualifies for a 50% fee credit.
- b) \_\_\_\_\_ My property is tax assessed as agricultural, and covered by a Soil Conservation and Water Quality Plan that is approved by the Charles Soil Conservation District. Therefore my property qualifies for a 50% fee credit.

**3. For non-residential property, verify and check which of the following applies:**

- a) \_\_\_\_\_ The development or subdivision was constructed after July 1, 2001, and meets the 2000 Maryland Stormwater Design Manual Volumes I and II, therefore qualifies for a 50% fee credit.
- b) \_\_\_\_\_ The development was constructed prior to July 1, 2001, but includes the use of stormwater management facilities which meet the 2000 Maryland Stormwater Design Manual Volumes I and II standards as verified by a professional engineer, and therefore this property qualifies for a 50% credit. A statement and description from a professional engineer is required.
